Annex A

Rules on Use and Management of the Collective Mark should include:

- a) the names, addresses and their titles of the members using the collective mark;
- b) principles and procedures for the use of the collective mark;
- c) the quality of the commodity for which the collective mark is used;
- d) rights and obligations in connection with the use of the collective mark;
- e) the liability for members violating the rules of administration and use of the collective mark; and
- f) the inspection and system of supervisory oversight for the commodity for which the collective mark will be used.
- g) in accordance with Article 23 of the Sub-Decree on implementation of the law on mark, trade name, and act of unfair competition, applicant shall notify in writing of any change in the regulation which affects the governing of the use of collective mark to the Department of Intellectual Property Rights.
